Guidelines with respect to Competition Application Form (CAF) 2019

Dear Parents

Greetings from Brainobrain! Welcome to a day of celebration!

Kindly read the following instructions, before filling the CAF

- 1. Only those children completed minimum BOB Level 1 and Little BOB Module 1** as on the 16th Jun 2019 and those who had completed 10 levels are eligible to participate in the competition. **Please note there is no T Category or 40 Pages since last year.**
2. Any children who had discontinued from the program will be eligible to participate in the Competition only after they had re-enrolled to the program and also paid the level/module fees in full upto the present level/module re-enrolled.
3. Children will be eligible only if all arrears of fees for the level/module completed and the present level/module undergoing are paid in full.
4. Filled in CAF should be handed over to the Center on or before 23 Jun 19 along with a Regn fee as per CAF. The Company reserves the right to accept application form submitted after the due date, a late fee as per CAF. The Fees once paid is neither refundable nor transferable.
5. Kindly pay attention to verify the authenticity of all the details incl the date of birth (DOB) are entered in the CAF.
6. After scrutiny of the completed CAF, a child will be permitted to appear the competition for a particular **category will be allocated by the Company**, based on certain common criteria like level the child completed, age of the child, duration taken to complete the level completed, etc. The company's decision in this regard will be final.
7. If the DOB in CAF differs with the Student Application Form (SAF), DOB as be SAF will only be considered. If any other discrepancy in filling up the CAF found, the registration of the child for the competition may be altered suitably for a particular category or even rejected. The company's decision in this regard will be final.

8. After registration of the completed CAF, the Hall tickets cum Category Sticker and the T-Shirt can be collected from the Center, before the day of competition. Students will be allowed to take part in only one category as per Hall ticket issued/Category Sticker.
9. Best efforts will be made by the Company to invite a good caterer for sale of Food, Water and other eatables at the venue. *The company will not be responsible for the quality, quantity or rate or service by the caterer. Parents/kids may choose to purchase or not any item from the caterer. Hence, we recommend that the parents shall make their own arrangements to bring/buy “drinking water, food and other eatables”.*
10. The Competition timing for each category will be displayed in the Hall ticket. Students shall be present at the venue **ONLY** 30 minutes before the allotted time of the competition and **not before, to facilitate crowd management.**
11. Students will be permitted to take part in the competition, only on producing the Hall ticket and Category Sticker and only on the timing mentioned on the hall ticket. Any change in timing will be intimated to the center and displayed at the venue.
12. Students are requested to keep the Hall tickets cum Category Sticker safely. Duplicate Hall tickets and Category Sticker will be issued only against a penalty payment of Rs.250 per Hall Ticket and Category Sticker.
13. Entry to the Competition Exam Hall & Main Auditorium Hall during the competition exam time & the prize distribution ceremony will be restricted only to the children and faculties. The parents/others accompanying the children may watch Audio-Visual of the forenoon and afternoon program at the designated area of the hall outside the Main Auditorium. This is to ensure comfort and safety of the children and smooth conducting the competition exam and prize distribution ceremony. We humbly request cooperation of all.
